

#### **Authority for Operations**

If any one or more of us dies, this authority shall be binding on our respective executors, administrators, legal personal representatives and all persons claiming from or under us as to all documents, acts, matters and things done or executed in terms of this authority before receipt by ANZ of notice of its revocation.

We shall give you immediate written notice of any change in the membership of the Partnership/Firm.
