Should we fail, upon your request, to hand to you immediately the new draft, invoices, and any other documents required as mentioned above, you are authorized to forward the invoices and other documents accompanying the draft of the transferee to your principals without any responsibility on your part for payment of any difference between the amount of the transferee's draft and the amount authorized to paid under the original Letter of Credit.
- (c) We hereby irrevocably transfer the abovementioned credit on exactly the same terms and conditions to _____
as a Credit opened in their favour for account of the buyer mentioned in your principal's instructions. We hereby renounce all rights thereunder and you may remit the documents which you receive from the new beneficiary direct to your Principals without further reference to us.
- (d) The original advice of Credit is returned to you herewith and we shall be glad if you will notify the new beneficiary by mail at our expense. Alterations to the Credit may be notified to the new beneficiary after reference to us.
- (e) Neither you nor your Correspondents shall be responsible for the description, quantity, quality or value of the merchandise shipped under the transferred Letter of Credit, nor for the correctness, genuineness or validity of the documents, nor for any other cause beyond your in their control.
- (f) (where paras (a) and (b) apply) We agree to be charged with interest for the period, if any, between the date of your payment to the transferee until the date of payment of the documents under the original Letter of Credit, and with any charges incurred by you or your correspondents in connection with transferred Credit.
- (g) Please debit our account/ We enclose our cheque in payment of your transfer commission and we agree to pay on you on demand expenses you may incur in connection with the transfer.
