
When you log into ANZ Transactive - Global from **Monday 14 May 2018**, you will notice the following additional functionality:

# **Payment Enhancements**

### 1. Restricted Templates:

You can now restrict payment templates to limit changes to your beneficiaries in a payment. Specifically, new beneficiaries cannot be added to a payment created from a restricted template and beneficiary details cannot be changed.

To create a restricted template, select the **Disable Beneficiary Changes for Payments created from this Template** checkbox:




For Pay Bill templates (available in Australia only), select the **Disable Biller changes for Payments created from this Template** checkbox.

#### 2. Restricted File Imports:

You can now restrict file imports to limit changes to your beneficiaries in a payment. Specifically, new beneficiaries cannot be added to a payment created from a restricted file import and beneficiary details cannot be changed.

To create a restricted file import, select the Disable Beneficiary Changes checkbox:

#### **New Payment File Formats:**

Australian customers can now import the following payment files:


- 1. **CSV**: Import a domestic payment as one batch of payment instructions
- 2. **MT101**: Import an International or RTGS payment as one or more payment instructions. A debit is processed for each transaction in the file.
- 3. **BPAY**: Import multiple BPAY payments to one or more billers in a single file. A debit is processed for each transaction in the file.

## Administration Enhancements (Australia customers only)

#### 1. Role Management:

Role Management has been introduced so that you can customise your own user roles to meet the needs of your organisation.



## 2. New Administration Reports:

- 1. **User Details Report:** Provides a report detailing a user's information, their roles and associated permissions, including account access and the applications that are assigned to the user
- 2. **User Activity Report:** Provides a report detailing a user's interaction with the system and includes the timestamp, IP address, service, function and action involved. This report is generated from the Report Profiles screen.
