### **Integra Super compliance statement**

ING MasterFund (SFN: 292 916 944, SPIN: MMFO146AU) (the Fund) is a resident regulated superannuation fund within the meaning of the Superannuation Industry (Supervision) Act 1993 (SIS).

The Trustee of the Fund is ING Custodians Pty Limited (ABN 12 008 508 496, AFSL 238 346) (INGC). INGC is a subsidiary of ING Australia Limited (ING Australia) (ABN 60 000 000 779).

The Trustee confirms the following statements on behalf of INGC.

It is the Trustee's intention to manage the Fund in compliance with the SIS laws, the relevant requirements of the Corporations Act and guidelines issued by both the Australian Securities and Investments Commission and the Australian Prudential Regulation Authority.

The Trustee certifies that the Fund is not subject to a direction under section 63 of SIS.

The Trustee certifies that the Fund accepts superannuation guarantee contributions as well as other additional employer contributions.

The Trust Deed governing the Fund also allows benefits to be transferred or rolled, from other resident regulated superannuation funds or superannuation products and allows benefits to be transferred or rolled over to other resident regulated funds.

Payments should be accompanied by: employee name, the employee's current Integra Super member number (these details can be found on the reverse of this form) together with the type of contribution you are making.



## Choice of Superannuation Fund Fund nomination form – Integra Super

If you are eligible for Choice of Superannuation Fund, this form provides a simple way to select Integra Super as the superannuation fund to which your employer will make contributions on your behalf.

Integra Super can be nominated as your Choice of Superannuation Fund, however you should be aware of the following requirements:

- you must have an existing Integra Super member account; and
- contributions from employer(s) (other than the employer that originally established your Integra Super member account) will only be accepted after you have transferred to the Integra Super Personal Division.

#### You can use this form instead of completing PART B of the standard choice form your employer may issue you.

On the reverse side of this form you will find a letter from the Trustee stating that Integra Super:

- is a complying superannuation fund; and
- will accept contributions from your employer.

The form also outlines how your employer can make contributions to Integra Super.

#### You will need to:

- complete any blank fields your membership number and account name can be found on your last Integra Super statement
- sign and return the completed form to your employer.
