 - (c) this Standing Order is subject to any arrangement now subsisting or which may hereafter subsist between me/us and the Bank in relation to my/our account or any banking accommodation afforded to me/us;
 - (d) the Bank may in its absolute discretion effect such Standing Order after the due date upon receipt of sufficient moneys in my/our account to enable such payments to be made;
 - (e) the Bank may in its absolute discretion conclusively determine the order or priority of payment by it of any moneys pursuant to this or any other order or cheque which I/we have previously or may hereafter give to the Bank or draw on my/our account;
 - (f) the Bank may in its absolute discretion terminate this Standing Order as to future payments at any time by notice in writing to me/us or without notice at any time after being advised by the payee that no further payment is required;
