- Existing customers can open additional account(s) under their current CIF with one form of ID document, the identification documents can be either a *Primary or ^Secondary document

RECENT ARRIVALS defined as "in the country less than 6 weeks" - there is an exemption for these parties whereby one Primary photographic document is acceptable.

- *Primary (Government issued) photograhic or non-photographic documents must include these information:
- (i) Full name
- (ii) Date of Birth
- ^ Secondary documents must include these information:
- (i) Full name
- (ii) Date of Birth or Residential Address
