

Terms and Conditions

1. Name of the promotion: Your time to make Back To School enjoyable.

3. Eligible Customers: Active Primary & Supplementary Credit Cardholders of ANZ Classic Credit Card, ANZ Gold Credit Card, ANZ Platinum Credit Card and ANZ Signature Priority Banking Platinum Credit Card ("Cardholders") in good credit standing issued by ANZ Bank Vietnam Limited ("ANZ") are eligible for this promotion.

4. Registration Criterion:

- 3.1 To participate in this promotion, Cardholders need to register by sending a registration SMS in the required format "ANZ <Lego Code>" (Lego codes: Planes, Batman, Lego Movie), e.g.: 'ANZ Batman' to 8069 anytime during the Promotion Period and will receive a confirmation SMS from ANZ
