Payment Mode	 Cash Payment Cash Payments can be made at all ANZ branches. For full list of ANZ branches, visit anz.com.sg. Cheque Payment Cheque should be crossed and payment made to Australia and New Zealand Banking Group Limited. Interbank GIRO You may arrange to have the full or minimum amount deducted from your bank account each month. AXS Stations and SingPost Self-Service Automated Machines (S.A.M™) You may pay your monthly ANZ Credit Card bill at any AXS Stations, or SAM™ situated island-wide.
Minimum Payment	Accounts with Outstanding Amounts below the Credit Limit \$\$50 or 3% of the total principal outstanding balance, whichever is higher, and any overdue amount. Accounts with Outstanding Amounts above the Credit Limit 3% of the total principal outstanding balance plus the amount in excess of the Credit Limit and any overdue amount.
Repayment Period	Interest-free and up to 51 days on your purchase.
Credit Limit	The overall credit limit for your Credit Card Account(s) and/or Personal Line of Credit (i.e. MoneyLine) is up to four times of your monthly income if your annual income is above \$\$30,000. If you have a salary increment and would like us to revise your credit limit, please submit the relevant income documents for our review.
Card Cancellation	For Card Accounts that are not active through any Card Transactions over a period of 12 months (or such other period as we may determine from time to time), we reserve the right to suspend or terminate your Card Account(s).
Interest Charges for Card Transactions	 Effective interest rate: 25% per annum If payment is not made in full by the Payment Date, interest charges will be calculated on a daily basis on all transactions in both the current statement as well as next month's statement from the transaction date until the date, full payment is received. If we do not receive the minimum payment from you by the Payment Date, you are considered to be in default. If such payment is still not received by the date of the next billing statement, we may vary the interest rate applicable to your Card Account to 28% per annum. The prevailing interest rate will be reinstated once you no longer have two or more defaults in the past 6 months and this will take effect from the first working day following the date of the next billing statement after the minimum payment is made in full.
Late Payment Charges	\$\$60 per month will be charged to your Card Account if the Minimum Payment is not received by Payment Date.

Cash Advance	\$\$15 or 5% of the amount withdrawn, whichever is higher, plus finance charge of 28% per annum on the amount withdrawn calculated on a daily basis from the date of withdrawal until the date payment is made in full.

Cross-Border Transactions	 Fees for Foreign Currency Transactions Card Transactions (including online and overseas transactions) effected in US dollars will be converted into Singapore dollars. Card Transactions, other than US dollars transactions, are converted to US dollars first before being converted to Singapore dollars based on the rate determined by the respective card associations, namely Visa or MasterCard. This exchange rate is applied on the date the Card Transaction is posted to the Card Account and may be different from the rate in effect on the date of the Card Transaction. All foreign currency Visa Card Transactions (including online and overseas transactions) are subject to a fee of 2.5% on the Singapore Dollar amount, which includes a 1.0% fee imposed by Visa on us. Dynamic Currency Card Transaction (including online and overseas transactions) is converted into Singapore dollars via dynamic currency conversion (a service offered at certain ATMs and merchants which allows a cardmember to convert a transaction denominated in a foreign currency to Singapore Dollars at the point of withdrawal/sale), you acknowledge that the process of conversion and the exchange rates applied will be determined by the relevant merchant or dynamic currency conversion service provider, as the case may be. Foreign currency Visa Card Transactions (including online and oversess transactions) converted via dynamic currency conversion as the converted Singapore Dollar amount, which includes a 0.8% fee imposed by Visa on us. Singapore dollar transactions processed outside Singapore All Visa Card Transactions (including online transacted: A) with a local merchant whose payments are processed through an overseas intermediary; or B) with a merchant who is registered as an overseas merchant regardless of its actual location, are subject to a fee of 2.5% on the singapore Dollar amount, which includes a 0.8% fee imposed by Visa on us.

Payment Hierarchy	If the outstanding is not paid in full, the payment received is first applied to all outstanding fees and interest followed by the outstanding balance.
