

Terms and conditions for ANZ's Access All Areas competition

1. Information on how to enter and prizes forms part of these conditions of entry. Entry into the competition constitutes acceptance of these terms and conditions.
2. Entry is open to all Australian permanent and contracted employees of Australia and New Zealand Banking Group Limited ('ANZ'). Sponsorship Australia staff and staff who are directly involved in the competition are not eligible to enter.
3. The promotion commences at 9.00am AEDST on Monday 16 November 2015 and closes at 5.00pm AEDST on Wednesday 16 December 2015 ("Promotional Period").
