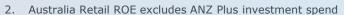

RETURN ON EQUITY¹ FY23

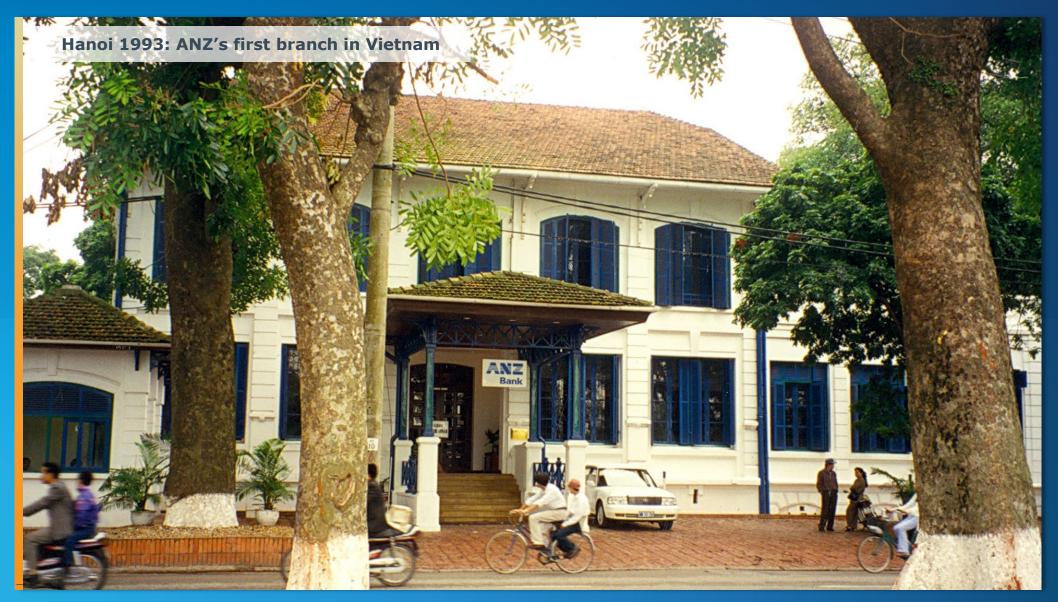
