The Distribution Rate is calculated in accordance with the Note Terms as 70% of the aggregate of the Bank Bill Rate (refer 3D.6) and the Margin (refer 3D.8) (together the "Aggregate Rate"). The figure in 3D.10 represents 30% of the Aggregate Rate (ie the current corporate tax rate) - this amount is deducted from the Aggregate Rate to calculate the Distribution Rate (refer 3D.12) under the Terms. # 3D.13 Comment on how total distribution rate is set

The Distribution Rate (refer 3D.12) is calculated under the Note Terms (refer to 3D.11) and is not adjusted for a Franking Rate of less than 100%. As such, the adjusted Distribution amount contained in 2A.9 and 3A.1b cannot be directly calculated by reference to the Distribution Rate. Refer to clause 3.2 of the Note Terms and the ANZ CN9 Prospectus dated 22 February 2024 for details of how the Distribution amount is adjusted for an assumed Franking Rate of 70% to reflect the unfranked component of the Distribution.
