## Overview of changes

This notice provides important detail about changes to your OnePath investments and the way they are managed.

As a result of the sale of ING Investment Management (INGIM) to UBS Global Asset Management (Australia) Limited (UBS GAM), OnePath has undertaken an extensive review of its investment strategy and fund offerings to ensure that it continues to meet the investment needs of its customers.

This review has resulted in new fund names, changes to OnePath's underlying investment strategy and new underlying investment managers. Additionally, a new suite of Product Disclosure Statements (PDSs) have been issued and other operational changes made.

Together, these changes will ensure OnePath continues to deliver investment solutions that are competitive, efficient and relevant to the needs of our investors.

## Fund name changes

All existing ING named funds on our investment menu have been renamed as 'OnePath' funds. For example, the 'ING Balanced Fund' is now known as the 'OnePath Balanced Fund'. See the following tables for a mapping of old fund to new fund name.

## OnePath Investment Strategy

We are changing our investment strategy such that we are moving from a 'single' asset manager, ING Investment Management (Australia), (INGIM), and the following changes will occur:

- a. New underlying investment managers who are specialists will be appointed to manage OnePath single asset sector funds. These new managers have been appointed for their expertise in managing specific asset classes and are listed by fund in the below table. In essence INGIM will be replaced by more than one specialist manager.
- b. A new investment style is to be introduced across the ING heritage diversified, multi asset sector funds that will move from a purely active style to a blended active and passive investment style. The passive component will be achieved through exposure to index funds, which are designed to achieve smoother performance against nominated benchmarks.

c. Through the introduction of more than one manager for each asset class the ING diversified funds will move from a 'single' manager investment strategy to a multi-manager strategy by definition.

A summary of the underlying, investment managers by fund and the relevant change in investment strategy and style is represented in the table below.

There will be no change to the existing investment processes, investment objectives and risk profiles of the newly named OnePath diversified funds.

There will be no change to fees and charges as a result of these changes.

## Asset transition

The appointment of each new, underlying investment manager becomes effective on or around 1 April 2012. We will conduct a transition of the underlying securities (assets) to each new, underlying investment manager. This transition will be conducted over a period of time such that each new manager's appointment becomes effective around early April 2012. During this transition period an appointed specialist asset transition manager will be responsible for managing the relevant investment funds according to existing fund objectives, risk profiles and current asset allocation ranges.

# Changes to benchmark asset allocations

The asset allocation, as disclosed for each fund in the PDS, is the neutral allocation for each asset class. This has been changed for some funds.

In summary, these changes:

- 1. are within the overall, current growth /defensive allocations;
- 2. remain within the existing low to high ranges declared in the relevant PDSs;
- 3. and do not affect the existing, disclosed investment objective for each investment fund.

## New Product Disclosure Statements (PDS)

All of the changes noted above are effective from 27 February 2012. A new PDS will be updated with details of each underlying manager for each of the OnePath funds. This will be effective from the 27 February to reflect OnePath's decision to move the heritage ING diversified funds to a new multi-manager strategy. New PDS documents contain up-todate information about all investment funds and investment managers available through OneAnswer products.
