TARGET MARKET DETERMINATION

PURPOSE OF THIS DOCUMENT

This target market determination is made by ANZ under section 994B of the *Corporations Act 2001* (Cth). Its purpose is to describe who this product has been designed for, conditions under which the product must be distributed and how this document will be monitored for ongoing appropriateness.

TARGET MARKET

ANZ Progress Saver has been designed for customers who:	Key attributes of ANZ Progress Saver that make the product appropriate for the target market:

<ul style="list-style-type: none">• Want to earn interest on amounts in the account and who may want the option of also earning bonus interest (subject to market rates);	<ul style="list-style-type: none">• Interest: Tiered variable base rate of interest earned on funds in the account. When a minimum deposit, and no transactions (including fees or charges to the account) or withdrawals are made in a calendar month, variable bonus interest is also payable.
<ul style="list-style-type: none">• Want the ability to make and receive payments through some payment methods; and	<ul style="list-style-type: none">• Payment methods: Payments can be made through a range of methods, including digitally and via ANZ Phone Banking. An ANZ Access Card may also be requested. Cheque facilities are not available.
<ul style="list-style-type: none">• Are comfortable paying transaction fees for some types of transactions (other than for Internet Banking Transactions*).	<ul style="list-style-type: none">• Fees: No fees are charged for Internet Banking Transactions*; fees charged for transactions which are not included ANZ Transactions*.

DISTRIBUTION CONDITIONS

ANZ applies the following conditions and restrictions to the distribution of ANZ Progress Saver so that the product is likely to be provided to customers in the target market.

Training & Accreditation	<p>ANZ Progress Saver can only be provided to customers by ANZ directly or through the following persons:</p> <ul style="list-style-type: none"> • Authorised ANZ staff who are accredited and trained. 	<p>So that:</p> <ul style="list-style-type: none"> • checks are conducted on matters like qualifications and past conduct for ANZ staff involved in the distribution of ANZ products; and • ANZ staff responsible for providing products understand the distribution process they are required to comply with when distributing ANZ products, as well as the legislative framework relevant to their activities.
Process	<p>ANZ Progress Saver can only be provided to customers by following ANZ's customer application and product selection process, including making relevant enquiries into the customer's product needs.</p>	<p>So that enquiries are made to determine whether the product meets the likely needs, financial situation and objectives of the customer.</p>

REVIEW THE TARGET MARKET DETERMINATION (TMD)

ANZ will review the TMD periodically to ensure it remains appropriate.

Periodic Reviews of the TMD	Timing
<ul style="list-style-type: none">Initial review	<ul style="list-style-type: none">No later than 18 months from the date the TMD is made.
<ul style="list-style-type: none">Subsequent ongoing review	<ul style="list-style-type: none">No later than 18 months from the date of the previous review.

Review Triggers

In addition, ANZ will review this document earlier if one or more of the following occurs, where they reasonably suggest that the TMD is no longer appropriate:

- There is a material change to the product or its distribution.
- There is a change in law or its application, a change in relevant industry code, an AFCA determination, a court decision, or ASIC or other regulatory guidance that materially affects the product.
- There is a significant increase beyond expected levels in complaints or disputes, or a significant change in the nature of complaints or disputes relating to the product.
- ANZ has information about the way in which the product is being distributed, operating or being used by customers that reasonably suggests the TMD is no longer appropriate.
- Any other event occurs or information is received (for example, significant dealings in the product that are not consistent with the TMD) that reasonably suggests the TMD is no longer appropriate.

REPORTING

Regulated persons must provide the following information to ANZ:
