

# ANZ BUSINESS ONLINE SAVER

## TARGET MARKET DETERMINATION

### PURPOSE OF THIS DOCUMENT

This target market determination is made by ANZ under section 994B of the *Corporations Act 2001* (Cth). Its purpose is to describe who this product has been designed for, conditions under which the product must be distributed and how this document will be monitored for ongoing appropriateness.

### TARGET MARKET

ANZ Business Online Saver has been designed for customers who:	Key attributes of ANZ Business Online Saver that make the product appropriate for the target market:
<ul style="list-style-type: none"><li>• Are running a business (whether or not for profit);</li></ul>	<ul style="list-style-type: none"><li>• <b>Eligibility:</b> ANZ Business Online Saver is only available for business purposes.</li></ul>
<ul style="list-style-type: none"><li>• Have (or are eligible to have) an approved ANZ account with which the Business Online Saver can be linked;</li></ul>	<ul style="list-style-type: none"><li>• <b>Linked account:</b> This account can only be operated when linked to an approved ANZ deposit account (the “<b>Linked Account</b>”).</li></ul>
<ul style="list-style-type: none"><li>• Have or expect to have funds in excess of the minimum threshold for interest which they intend to put on deposit and earn a variable rate of interest on (subject to market rates);</li></ul>	<ul style="list-style-type: none"><li>• <b>Interest:</b> A variable rate of interest is payable only on funds held in excess of the minimum balance.</li></ul>
<ul style="list-style-type: none"><li>• Are willing to accept online only access to their account; and</li></ul>	<ul style="list-style-type: none"><li>• <b>Deposits:</b> Funds can only be deposited by transfer from the Linked Account or via electronic transfer from certain other accounts.</li></ul>
<ul style="list-style-type: none"><li>• Require access to their funds on demand but who do not require the ability to make payments to third party accounts directly from this account.</li></ul>	<ul style="list-style-type: none"><li>• <b>Withdrawals:</b> Funds can be withdrawn on demand by transfer to the Linked Account. Unless otherwise agreed with ANZ, customers cannot withdraw funds by direct debit, transactions in branch or transfers to an account other than the Linked Account.</li></ul>

## DISTRIBUTION CONDITIONS

ANZ applies the following conditions and restrictions to the distribution of ANZ Business Online Saver so that the product is likely to be provided to customers in the target market.

<b>Channel</b>	<p>ANZ Business Online Saver can only be provided to customers through the following channels:</p> <ul style="list-style-type: none"> <li>• ANZ Commercial;</li> <li>• ANZ National Business Centre;</li> <li>• ANZ Digital<sup>1</sup>;</li> <li>• ANZ Branches; and</li> <li>• ANZ Private.</li> </ul> <p>ANZ Business Online Saver cannot be distributed by third parties. Brokers may refer customers to ANZ, however only authorised ANZ staff may decide to issue the product to a customer.</p> <p><sup>1</sup> This may include anz.com, ANZ App and ANZ Internet Banking.</p>	<p>So that ANZ only provides ANZ Business Online Saver if the customer's application is received through channels that are subject to appropriate conditions, controls and/or monitoring by ANZ.</p>
<b>Training &amp; Accreditation</b>	<p>ANZ Business Online Saver can only be provided to customers by ANZ directly or through the following persons:</p> <ul style="list-style-type: none"> <li>• Authorised ANZ staff who are accredited and trained.</li> </ul>	<p>So that:</p> <ul style="list-style-type: none"> <li>• checks are conducted on matters like qualifications and past conduct for ANZ staff involved in the distribution of ANZ products; and</li> <li>• ANZ staff responsible for providing products understand the distribution process they are required to comply with when distributing ANZ products, as well as the legislative framework relevant to their activities.</li> </ul>
<b>Process</b>	<p>ANZ Business Online Saver can only be provided to customers by following ANZ's customer application and product selection process. This process includes making relevant enquiries into the customer's product needs.</p>	<p>So that enquiries are made to determine whether the product meets the likely needs, financial situation and objectives of the customer.</p>

## REVIEW THE TARGET MARKET DETERMINATION (TMD)

ANZ will review the TMD periodically to ensure it remains appropriate.

Periodic Reviews of the TMD	Timing
<ul style="list-style-type: none"><li>Initial review</li></ul>	<ul style="list-style-type: none"><li>No later than 18 months from the date the TMD is made.</li></ul>
<ul style="list-style-type: none"><li>Subsequent ongoing review</li></ul>	<ul style="list-style-type: none"><li>No later than 18 months from the date of the previous review.</li></ul>

### Review Triggers

In addition, ANZ will review this document earlier if one or more of the following occurs, where they reasonably suggest that the TMD is no longer appropriate:

- There is a material change to the product or its distribution.
- There is a change in law or its application, a change in relevant industry code, an AFCA determination, a court decision, or ASIC or other regulatory guidance that materially affects the product.
- There is a significant increase beyond expected levels in complaints or disputes, or a significant change in the nature of complaints or disputes relating to the product.
- ANZ has information about the way in which the product is being distributed, operating or being used by customers that reasonably suggests the TMD is no longer appropriate.
- Any other event occurs or information is received (for example, significant dealings in the product that are not consistent with the TMD) that reasonably suggests the TMD is no longer appropriate.

## REPORTING

Regulated persons must provide the following information to ANZ:

Complaints	<ul style="list-style-type: none"><li>Whether any complaints relating to the product were received during the reporting period; and</li><li>If so:<ul style="list-style-type: none"><li>the number of complaints received during the reporting period; and</li><li>the substance of those complaints and any general feedback relating to the product or its performance.</li></ul></li></ul>	Every calendar quarter.	As soon as practicable and in any case within 10 business days of the relevant reporting period.
