

## **TERMS AND CONDITIONS**

- 1. **ame of the promotion:** Megastar Movie Ticket Buy 1 get 1 free
- **2. Promotion period:** From 15<sup>th</sup> August 2013 to 15<sup>th</sup> August 2014 or until full utilisation of complimentary tickets, whichever is earlier
- 3. Area applicable to the promotion: Megastar Cineplex, all outlets in Vietnam.

## 4. Promotion offers:

- Buy 1 Megastar 2D movie ticket by ANZ Credit Card and get 1 complimentary 2D Megastar movie ticket.
- Buy 2 Megastar 3D movie ticket by ANZ Credit Card and get 1 complimentary 3D
   Megastar kid movie ticket
- 10% discount for My Combo and Couple Combo
- **5. Eligible customers:** customers who have ANZ Credit Cards issued by ANZ Bank (Vietnam) Limited

## 6. How to redeem free tickets:

- Cardholder makes a qualified purchase at Megastar and text VE2D to 8069 to receive an
  electronic code to redeem complimentary 2D ticket or text VE3D to 8069 to redeem
  complimentary 3D kid ticket. An electronic code includes both characters and numbers and is
  sent to the registered mobile number of cardholders
- Cardholder presents the SMS with a code from ANZ together with the receipt at any Megastar to redeem a complimentary 2D or 3D ticket. Return of the receipt is not allowed.
- Megastar complementary ticket is defined as 2D or 3D movies ticket issued by Megastar and can be used at any weekdays or weekend subject to Megastar availability.

## 7. Other terms and conditions:

- The eligible cardholder includes both Primary & Supplementary cardholders who must spend (together) minimum 3 million VND in the month they receive free Megastar movie ticket(s) (defined as solar month from 1<sup>st</sup> to 31).
- Complementary tickets can only be redeemed on the same day, same outlet and movies show with the tickets purchase by ANZ credit card. The receipts with different date, movie show or outlet are not eligible to this promotion.
- Maximum two 2D tickets are given away per account per week. Maximum 350 free 2D tickets per week and 65 free 3D tickets are given away per week. One account includes both primary and supplementary cards. A week is defined as from 0 am Friday to 24 pm Thursday (GMT+7).
- The offer is not applied for online booking, sneak shows, M-Cinema shows at Paragon



- Tickets purchased at the box office or through MegaStar Website are only for individual use, cannot applied for resale. Violation of this term may be subject to prosecution by local authorities.
- Megastar has the right to retain the ticket purchase receipt in exchange of free ticket given to cardholders.
- To be eligible to the promotion, cardholders have to be assured that mobile number is updated correctly by calling 1800-1559. ANZ only release the electronic code to registered mobile phone numbers. Two (02) working days is required for ANZ to update cardholder's mobile number and be able to release a code to qualified cardholder. New cardholders are required to wait for four (04) working days from the date of activation to enjoy the promotion.
- The Cardholder agrees that if (i) his / her movie ticket and the electronic code are found to be fraudulent, (ii) cardholders spend less than 3 million in the month they send SMS or (iii) more than 2 tickets are redeemed per week, ANZ reserves the right to charge the cost of the tickets which Cardholder is not entitled to (VND85,000/2D ticket or VND150,000/3D ticket) to his/her ANZ Credit Card account
- The promotion is not applicable during Holiday (1/1/2014, 2/9/2013, Apr 30<sup>th</sup>, May 1<sup>st</sup>, Hung King Anniversary, Tet Lunar New Year (from 28<sup>th</sup> to the 10<sup>th</sup> of the first lunar month)
