



### **ANZ Travel Visa Signature Credit Card Bonus 2,000 Travel\$ Terms and Conditions**

1. The ANZ Travel Visa Signature Credit Card Bonus 2,000 Travel\$ promotion ("Promotion") is open to new-to-bank customers who apply for the ANZ Travel Visa Signature Credit Card (excluding supplementary credit cards) and cannot be used in conjunction with any other ANZ credit card promotions and/or offers unless otherwise stated.
2. New-to-Bank applicants, who successfully apply for the ANZ Travel Visa Signature Credit Card using the promotional application form and charge a minimum of S\$500, in single or multiple transactions, to the ANZ Travel Visa Signature Credit Card within thirty (30) days from the date the Credit Card is approved, shall receive the Bonus 2,000 Travel\$ ("Bonus Travel\$").
3. Only retail transactions charged to the ANZ Travel Visa Signature Credit Card will be considered for the Promotion. Ongoing instalment plans, cash advance, balance transfer, and any other fees howsoever called, including but not limited to, annual fees, cash advance fees, interest and late fees are excluded from the calculation of the spend amount for this Promotion. Retail charges debited and posted to the account of all Supplementary Cardmembers will be taken into consideration and awarded to the Principal Cardmember.
4. Upon meeting the spend criteria, each Principal Cardmember is entitled to a one-time awarding of the Bonus Travel\$, regardless of the number of transactions made or number of credit cards approved.
5. The Bonus Travel\$ will be credited to the Principal Cardmember's ANZ Travel Visa Signature Credit Card account within six (6) weeks after the spend criteria is met. The Bank reserves the right at its reasonable discretion to replace the Bonus Travel\$ with any other item of similar value.
6. Applicants who had cancelled their ANZ Travel Visa Signature Credit Cards in the last six (6) months prior to the date of application will not be entitled to the Bonus Travel\$.
7. The decision of the Bank on all matters relating to the Promotion is final.
8. The Bank reserves the right to vary the terms and conditions of the Promotion and/or to suspend or terminate the Promotion and/or vary the amount of Bonus Travel\$ given at any time at its reasonable discretion.
9. Terms and conditions stated in the ANZ Travel Visa Signature Credit Card Programme apply.
10. These terms and conditions shall be governed by the laws of Singapore and the applicant irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore.
11. A person who is not a party to these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
