

# The W.C.F. Thomas Charitable Trust

## Benefactor history - William Charles Frederick Thomas: 1863 - 1943

William Charles Frederick Thomas practised a very hands-on style of Methodism, as lived by his family. During his lifetime, Thomas was closely involved in the work of the Methodist Church and other charitable pursuits, for example in 1921 he became a Charter Member of the Rotary Club of Melbourne, the first Rotary Club in Australia.

Thomas was a prominent Australian businessman. He inherited and successfully grew his father's Victorian based flour mill and grain merchant business, W.C Thomas and Sons Pty. Ltd. In recognition of Thomas' service to the milling industry he was awarded the Order of the British Empire – Commander (Civil) [C.B.E.] in 1926 and was twice appointed the employers' representative by the Commonwealth Government of Australia at the International Labour Conference of the League of Nations in 1924 and 1930.

#### **Beneficiaries**

Thomas established the W.C.F. Thomas Charitable Trust in his Will. The aims of the trust are: "relief of poverty, advancement of religion, advancement of education, and such other purposes beneficial to the community as may be charitable though not falling under any of the preceding headings."

The Trust was established with an initial bequest of approximately £100,000. Funds were first distributed to charitable causes in 1944 and today the Trust gives approximately \$150,000 per year. In addition, Thomas also left substantial bequests in his will to Orana Family Services and Uniting Church Beneficiary Fund.

The W.C.F. Thomas Charitable Trust accepts grant applications from charitable organisations by invitation only. Mr. Ray Smith and ANZ Trustees are the trustees of the W.C.F. Thomas Charitable Trust.

### **Trust achievements**

The W.C.F. The trust also made a significant grant towards the building of the Timor-Leste embassy and cultural centre in Canberra.
