## The Founder

The Foundation which bears his name commemorates William Buckland, a highly successful businessman and pastoralist in the middle years of the 20th century. Initially involved in building the fledgling motor parts trade, his business interests expanded to include service stations, finance and investment companies and eventually a string of pastoral holdings in the eastern states and Northern Territory. He realised his great fortune by selling his private companies into public ones.

On his death in 1964, after bequests to his family and some favourite causes, William Buckland left the bulk of his large estate - £4 million - to establish a Foundation, the income of which was to be used in his words "to benefit a wonderful country and a wonderful people. Australia and Australians". Those interested in learning more of him can obtain a copy of his biography, William Lionel Buckland by David T. Merrett from ANZ Trustees or public libraries.

The Will which established the trust deed left half of the income "to divide... in each year among such public hospitals, public benevolent institutions or public benevolent societies in Victoria... and I hereby indicate to my Trustees my hope that in the division of such income, they will favourably consider charities for children". The other half he wished to apply to "public scientific or public educational purposes in Victoria". His attachment to the pastoral sector is indicated in his suggestion that his Trustees, in administering the public educational purposes should "give preference to agricultural and related pursuits".

Today, with careful stewardship by the Foundation's Trustees, William Buckland's legacy generates in the order of \$5.0 million annually which is distributed for charitable purposes. From its establishment until now, the Foundation has distributed over \$74 million.

## What the Foundation Funds

#### Mission

To support organisations, activities and projects that create lasting public benefit for the Victorian community.

#### **Focus**

The Foundation chooses to focus its support on:

- · health and community wellbeing, particularly for children and young people
- · scientific and educational activities, particularly in agriculture

Particular areas of interest are:

- · breaking the cycle of social disadvantage
- · enabling employment creation
- facilitating access to education
- · promoting sustainable land use

The Foundation can only provide funding to Victorian charitable organisations. The Foundation prefers to support proposals that:

- employ a collaborative approach;
- · have a specific geographic focus, particularly rural or regional Victoria;
- · demonstrate a multiplier and/or leverage effect;
- · come from well-governed organisations with strong leadership.

## Trustees' Overview

The ongoing impact of the global financial crisis on the 2010/2011 financial year, and the fact that we have made a number of forward commitments, has led to some very careful research, budgeting, and decision making – within the constraints of a reduced disposable income year.

We as Trustees are forever cognisant of our responsibility to carry out the wishes of William Buckland and therefore refer frequently to the terms of the Will for confirmation. Our decisions on the suitability of grant applications are carefully assessed and we are always looking for projects that are innovative and sustainable. We have also recently given favourable consideration to those 'not for profit' organisations under financial pressure as a result of the GFC.

As a result of relatively recent changes to legislation, the Trustees have spent a considerable amount of time negotiating an appropriate fee with the ANZ Trustees. Ms Cheryl Bart AO, the Chairman of ANZ Trustees, joined our Board for a short time and we thank her for her contribution. Ms Bart has recently been replaced by Ms Sarah Dunn, General Manager, Clients ANZ Trustees, and we are already benefiting from her input.

The diversity of grants given is reflected in the list on the following pages and the independent Trustees are most grateful to the ANZ Trustees staff, who have worked with us to fulfill the aims of our granting policy. We are also very grateful to Dr Rachelle Buchbinder who is the Chairman of The Victorian Medical Research and Technology Committee for her continued enthusiasm and guidance. A decision was made to increase our annual distribution to this committee to \$250,000.

Robyn Charlwood and Shaun Cannon greatly contributed to our decision making for the first half of the year and Louise Arkles and Chris Wootton have latterly provided astute and professional advice. We thank them all and especially Teresa Zolnierkiewicz, Head of Philanthropy, for her advice and valuable oversight.

Finally, I would like to sincerely thank my co Trustees, Jane Gilmour OAM, Sandy Clark and Graeme Sinclair. We have had a stimulating, exacting and interesting year and their friendship, support and input have been invaluable to me.

We have continued to support medical research in a small way through a \$200,000 allocation to the Medical Research and Technology in Victoria Program that is administered by ANZ Trustees on behalf of a number of charitable foundations. Through this fund we provide support for the purchase of equipment essential for research to take place. We are indebted to the Chair, Professor Rochelle Buchbinder, and other members of the Advisory Committee for their work in assessing the applications and recommending the grants.



#### **McAuley Community Services for Women**

McAuley Community Services for Women provides accommodation, services and support for women and children who have experienced homelessness, domestic violence and mental illness. Their work is focussed in the north-western region of Melbourne, but they also accept referrals statewide. The organisation provides practical support in terms of crisis accommodation, income security, food, clothes, legal and family arrangements, as well as emotional support.

The Buckland Foundation is supporting a three-year trial of an outreach program for women who have suffered domestic violence once they leave the safe house environments provided by the organisation.

Two specialist outreach workers will be employed to support women and children as they reintegrate into the community. The program seeks to prevent further instances of domestic violence and homelessness, improve the social, economic and educational outcomes for the women and children and to help rebuild the mother-child relationship, which has often been damaged through the experience of domestic violence.



#### Victorian Immigrant and Refugee Women's Coalition

The Victorian Immigrant and Refugee Women's Coalition is a peak body that represents over 65 migrant and refugee women's organisations and related agencies across Victoria. Based at the Queen Victoria Women's Centre in central Melbourne, this small organisation provides a suite of services including counselling and peer support, leadership courses and legal advice, as well as undertaking research into issues affecting the status of migrant and refugee women.

The Foundation is supporting a two-year pilot community development project to build social cohesion and increase leadership capacity for migrant women.

The project, Women Building Bridges, will take place in northwest and southwest Melbourne, both areas with high concentrations of recently arrived migrants. A pool of volunteer Women Champions will be established in each region. They will work with staff to undertake a range of community education and training activities, build networks and partnerships and provide advice, referral and support. A key focus of the work will be to address issues such as women's isolation, youth disengagement and mental health problems within families. The Victorian Immigrant and Refugee Women's Coalition believes that after the two-year pilot it will be in a strong position to continue the program through local council support, volunteers and ongoing partnerships with mainstream organisations.



#### Bush Heritage Australia

Bush Heritage Australia is a national organisation that protects Australia's biodiversity by acquiring and managing land of significant conservation value. Bush Heritage has established Beyond the Boundaries, a program to work in partnership with other landholders to support their efforts to make conservation a viable activity on their properties.

Nardoo Hills, in the Victorian Riverina goldfields, is the Victorian node of the organisation's strategy to protect grassy box woodlands ecosystems in south-east Australia. This is one of the highest priority areas of concern in Victoria for biodiversity conservation.

# The Buckland Foundation's support will allow Bush Heritage to develop a conservation planning tool for the region.

The plan, which will be developed in consultation with key stakeholders, particularly local landholders, will be used by Bush Heritage for management on its own properties, education and information for landholders in the region as well as for the implementation of land management agreements with property owners, such as Voluntary Conservation Agreements.



#### **Visionary Images**

Visionary Images is an arts organisation that works with disadvantaged or disengaged youth through art and contemporary communication media. Its work has been primarily focussed in Melbourne and it has developed a very effective model to involve young people (many of whom are referred by other agencies) in all stages of a creative arts project, thus building not only arts and creative skills, but also practical life skills in project management, collaboration and mutual respect.

The Buckland Foundation's support for the organisation is allowing it to implement a two-year pilot program for disadvantaged and disengaged youth in South-West Gippsland.

Twice-weekly workshops are being held in photography, video, animation, digital imaging and other skills. Works created will be exhibited in a shopfront in Wonthaggi to foster stronger connections between the young people and the broader community.





# Financial Report



## Investment Overview

The Trustees consider that, as the Foundation is a perpetual trust, the amount available for distribution to charities will be maximised over time if a relatively high proportion of the corpus is invested in growth assets, particularly equities.

They also judge it prudent to entrust day-to-day management of the funds to professional investment managers, within asset allocation ranges set by the Trustees. The investment managers for the financial year ended 30 June 2011 were:

- · ANZ Trustees Limited
- · Lend Lease Corporation Limited
- · Tyndall Investment Management Limited
- · Warakirri Asset Management Pty Ltd

The Management Expense Ratio (MER) is a measure of the level of expenses incurred by the Foundation. The MER, expressed as a percentage of the net assets of the Foundation, includes the administration fees, investment management fees and other expenses. The comparison with the previous year is shown.

# Investment Guidelines and Objectives

While the Foundation has a time horizon of perpetuity it is expected that the Investment Guidelines and Objectives will be reviewed by the Board of Trustees from time to time. The investment powers of the Foundation set out in William Buckland's Will included a number of restrictions which were varied by the Supreme Court of Victoria in 1993 and 2005 in response to application made by the Trustees.

#### 1. Asset mix

The great majority, and up to 100 per cent, of the Foundation's assets are to be invested in 'growth' (as distinct from debt) assets. 'Growth' assets include shares, property, convertibles, and even debt type assets that offer equity like returns.

#### 2. Management

The Foundation's assets should be managed by professional investment managers with a maximum exposure to any one manager/group of 50 per cent of the assets of the Foundation.

#### 3. Security diversification

At no time should the Foundation's exposure to a single risk asset (e.g. a company, or single property) exceed 10 per cent of the assets of the Foundation. The overall portfolio of assets should be broadly diversified to obtain a satisfactory yield without increasing risk by concentration in any industry, geographic location, company or individual.

#### 4. Investment objectives

The Foundation's investment objectives are to:


- maximise income, consistent with the modest growth of the real value of the Foundation's assets over time;
- target an income distribution in the region of 5 per cent of the average value of the Foundation's assets over each year; and
- seek to structure the portfolio such that the real income distribution is maintained and grows over time. It is anticipated that this objective, combined with the income distribution target, will mean that over time the capital value of the portfolio shall not decline by as much as the market during those periods where the market return is negative.

# **Investment Performance**


The movement in the capital value of the Foundation over recent years is shown in the chart below.

The Buckland Foundation recognises its income, on a 'cash received' basis using trust law definitions of income, to determine the amount it has available to distribute each year under the terms of the will. However, the accounts that are incorporated in this report also show the income on an accrual, or 'as earned' basis. The distinction is important as a significant part of the Foundation's income earned each year is in the form of franking credits from shares. Given that these have to be claimed back from the Australian Taxation Office, there is a delay of one year until these credits are received and thus recognised as being available for granting.

In 2010-2011 income on an accrual basis, or distributable income, has risen strongly, following the decline in the previous year caused by the impact of the GFC. While the amount earned, after all Foundation expenses, of \$4,736,930 is still below the levels prior to the GFC, it represents a strong rebound of earnings, up 13% from the \$4,182,079 in the previous year. It is also a healthy 5.6% net income return on average capital funds of \$87m over the year. The substantial 18% increase in income earned was from two of the three fund managers as well as a timely switch from a lower yielding direct property holding to high yielding term deposits.

However, the strong rise in income on an accrual basis has not translated through to a sharp increase in the amount received in cash, and thus available to be granted this year. Income received on a cash basis for the 2011 year was \$4,677,470, a slight decline from the \$4,733,563 received in the 2010 year. Most of the difference between the 'earned' basis of income and the 'received' basis is due to the lagged receipt of franking credits.
